AGREEMENT - PIT**

The undersigned participant(s) in the Races and Demolition Derby to be held at All Wheels Weekend at the Columbia County Fairgrounds on June 15, 2024, realize that such an event is hazardous. The undersigned releases All Wheels weekend and The Dayton Chamber of Commerce and the Columbia County Fairgrounds, employees, the event and race officials for any injuries sustained (temporary or permanent) by the undersigned during the course of the races or Demolition Derby. Permission is granted for all vehicles to be searched upon entry to the Pit area by the event staff or their designated representative. By signing below, you are agreeing that you have read and understand the Rules of Racing and Conduct and the Car Rules and failure to comply will mean immediate disqualification and\or dismissal off of the grounds. I/we herby acknowledge and accept the above release.
